Special Events

1. A Special Event Application was received from Penn Crossing Associations for a Block Party on Saturday, July 12th, 2008 from 11:30 am to 7:30 pm. They request that the street be blocked at Merchant Street between 10th Avenue and 11th Avenue. It is anticipated that approximately 40 - 78 people will attend.
2. A Special Event Application was received from the Graystone Society for the 11th Victorian Ice Cream Festival on Saturday, July 12th, 2008 from 7:00 am to 6:00 pm. The applicant is requesting the closure of First Avenue between Maple Avenue and Harmony Street, Police Oversight and approval for a Banner across Lincoln Highway at First Avenue. It is anticipated that approximately 2000 people will attend. Also they made a request for Waiver of Fees by the City of Coatesville.
3. A Special Event Application was received from Trinity United Bible Church for the outdoor church service on the following dates: Friday, July 25th, Saturday July 26th and Sunday July 27th, 2008 from Friday morning to Sunday afternoon in the Vic Abdalal Park. It is anticipated that approximately 100-150 people will attend. They request the City to provide them with electrical outlets.
4. A Special Event Application was received from Street Ministry for the Outdoor Church Service for the following dates:
 - Monday June 23, Tuesday June 24, Wednesday June 25; Monday July 28, Tuesday July 29, Wednesday 30; Monday August 25, Tuesday August 26, Wednesday August 27. from 6:00 pm to 9:00 pm. They request that the street at 101 N. 5th Ave between Chestnut Street and Lumber Alley will be blocked. Also they made a request for Waiver of Fees by the City of Coatesville.
 - Saturday, July 26th, 2008 in the Ash Park. It is anticipated that approximately 100 people will attend. They request from the City to provide them with trash cans and electrical outlets. Also they made a request for Waiver of Fees by the City of Coatesville.
